Thanks for your interest in this event. This year, we are delighted to invite both the Real Estate Section and the Energy and Telecom Committee to join us. We plan to arrange for a bus leaving from and returning to the Anderson Regional Transportation Center in Woburn off Route 93, and encourage everyone to take the bus to facilitate camaraderie and minimize our carbon footprint.

The cost for downhill skiing at Bretton Woods is \$50/person, heavily discounted from the weekday rate of \$70. After depositing the downhill contingent, the bus will head across the street to the Nordic Center for those coming to cross-country ski. The bus will stay at the Nordic Center, departing in time to reach the après-ski back at the Base Lodge. The cost for XC is \$14/person, also reduced from the standard rate. Rental of XC skis is available at the Nordic Center, which has a 100 km network of trails.

For the truly adventurous, Bretton Woods also has a zip line Canopy Tour. This 3.5 hour tour involves 10 cable zip lines and 2 sky bridges and begins at the Bretton Woods Base Lodge.
