



2013 Boston Bar Association Summer Judicial Internship Application

Several Massachusetts State Courts are now accepting applications for interns for Summer 2013. This unpaid, non-credit* internship provides students the opportunity to work directly with a judge, observe courtroom proceedings and enhance their legal research and writing skills. The Boston Bar Association's Diversity & Inclusion Section's Pipeline and Recruitment Committee is helping to connect the judges with potential interns.

Students who have completed their first year of law school and are able to work at least 15 hours per week will be considered**. Diverse students are strongly encouraged to apply. A flexible schedule is available to accommodate other commitments.

Interested students should complete the attached application and submit it along with a cover letter, resume, and a letter of recommendation from a law school professor. Applications will be collected on a rolling basis with a deadline of March 1, 2013. Students are encouraged to indicate placement preferences, however those placements cannot be guaranteed.
